nos contagian a nosotros todos tenemos temor a contagiarse
a unos a otros yo tengo dolor de cabeza y tos pero no
me ise el tes del corona virus por que ban a
mentir que no ay corona virus por que no ablan con
la berdad ni acen el tes como debe ser yo trabajo
en la Clinica y ay personas aisladas con el corona virus

I am in the ICE detention and ICE is ignoring the petitions of the Federal Court to set free those who are elderly and could be infected with COVID. I am witness to seeing people be infected. I saw elderly men who were working in cleaning. These people had diabetes and were on insulin. Because they have not been freed, they were infected with Coronavirus. They are isolated in a room with very little care. If they had been freed they would not have been infected. They do not have serious crimes - they are in level green and blue.

The disinfectant liquids are not effective - they give us allergies. People in my unit are also experiencing burning in their eyes. I am someone who has anemia and low iron, and have a hernia and other illnesses. I've had a cough since I got to this detention center. I had a fever and headache, and achy muscles. All they give us is allergy pills or pain pills and say there is no Coronavirus.

I understand their fear of losing their jobs if they set us free. But they are exposing their families when they leave here for their homes and then they infect us. We are all afraid of infecting each other. I have a headache and cough but I did not get tested for COVID because they lie that there is no Coronavirus. Why can't they tell the truth? They don't even do the test the way it should be administered. I work in the clinic, and there are people in solitary with Coronavirus and then they come to our units to say that no one has been infected?
